#### **Rating Rationale**

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D)on the Rs. 36.26 crore bank facilities of Ajanta Spintex Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### **About the Company**

Ajanta Spintex Limited (ASL) is a Guntur based company incorporated in 2010 by Mr. Dhana Reddy. It is engaged in manufacturing of cotton yarn with spindle capacity of 24,200 spindles in the count range of 20's to 60's. The manufacturing facility is located at Kakani Village in Guntur District (Andhra Pradesh).

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
