Rating Rationale

Acuité has withdrawn the long-term rating of '**ACUITE B** (**read as ACUITE B plus**) and the short term rating of '**ACUITE A4** (**read as ACUITE A four**) on the Rs. 10.00 crore bank facilities of Magnus Composites Synergies Private Limited (MCSPL). This rating is now withdrawn, indicative and is based on best available information.

The rating is being withdrawn on account of request received from the company and NOC received from the banker.

MCSPL, established in 2010, is an EOU export oriented unit promoted by Mr. Sushil Chandrakant Shah. It is engaged in manufacturing, designing and exporting of Fibreglass reinforced plastic (FRP) corrugated panels, fiberglass roofing sheets, wall panels and architectural products.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
