Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE BB-**' (read as **ACUITE double B minus**) from '**ACUITE BB**' (read as **ACUITE double B**) and reaffirmed the short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs. 22.00 Cr. bank facilities of Dynatech Tools and Devices (Bengaluru) Private Limited on account of information risk. The rating continues to be flagged as 'Issuer Not-Cooperating' and is based on the best available information.

About the Company

Bangalore based, Dynatech Tools and Devices (Bengaluru) Private Limited was incorporated in 2012. The directors of the company are Mrs. Geetha V. Shettigar, Mrs. Savithri Thimmaiah, Mr. Bellairu Damodar, Mr. Ballapatha D. Thimmaiah, Mr. Hemanth K. Vittal and Mrs. Vathsala Damodar. The company is engaged in manufacturing of high precision components for International machines tool and aerospace industry. It exports to reputed clients like, DMG Mori Aktiengesellschaft, Bosch Limited and Titeflex Europe SAS among others.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
