Acuité has downgraded the long-term rating to '**ACUITE B+** (**read as ACUITE B plus**) from '**ACUITE BB-**' (**Read as ACUITE double B minus**) on the Rs.25.00 crore bank facilities of Vedant Estates and Properties. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

The Pune-based, VEP is a partnership firm established in 2014 by Mr. Sandeep Agarwal and Mrs. Shashikala Agarwal. The firm is engaged in development of residential and commercial properties and is a part of Vedant group which has executed 5 projects since 2007. Presently VEP is executing a commercial and residential project 'Kingston Aura', which is 81:19 joint development between developer (Vedant Estate and properties) and land owners.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
