Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minuso)n the Rs. 8.00 crore bank facilities of Collective Foods India LLP (CFIL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Collective Foods India LLP (CFIL) based out of Jamnagar is a Limited Liability Partnership firm incorporated in May, 2018. The firm is promoted by Mr. Ramniklal Akbari, Mr. Jayeshkumar Akbari and Mr. Harsh Akbari. The firm will be starting with processing of ready to eat meal products under the brand name - 'Make Your Meal'. The product will have a shelf life of 3 to 6 month. The firm plans to setup its manufacturing unit in Jamnagar having 116000 sqft area.
