Acuite has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 12.30 crore bank facilities of Shashi Prakash V (SPV). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

SPV is a Bengaluru based proprietorship concern established in 1991 by Mr. Shashi Prakash V. SPV is engaged in leasing out property at Yeshwanthpur in Bengaluru (Karnataka). The total land area is 21780 sq. ft. with building area of 44820 sq. ft. SPV has only one client i.e. Gokaldas Intimate wear Private Limited, which is one of the leading player in the garment industry. The operations of SPV commenced from 2002 after construction of the factory building in 2001.

### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
