Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE 'D'**) on the Rs.19.00 crore bank facilities of M S Ramayya Constructions Private Limited. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

M S Ramayya Constructions Private Limited is a Vishakha Patnam based company incorporated in 2004 promoted by Mr. Gummudu Ramesh, Mr. Rajubabu Peela, Mr. Mogga Naga Varalakshmi, M rs . Sita Ramayya Mogga, M rs . Dakshayani Mogga, M r . Sai Harish Rampe, Mr. Mogga Geetha Sankar, Mr. Sundar Syam Manohar Mogga. It is established to develop real-estate activities involving construction of residential apartments and commercial complexes in various parts of Vishakha Patnam and its surroundings.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité has endeavoured to gather information about the entity/industry from the public domain.
