Rating Rationale

Acuité has reaffirmed the long term rating of ‘**ACUITE D**’ (read as **ACUITE ‘D’**) on the Rs.19.00 crore bank facilities of M S Ramayya Constructions Private Limited. The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

About the Company

M S Ramayya Constructions Private Limited is a Vishakha Patnam based company incorporated in 2004 promoted by Mr. Gummudu Ramesh, Mr. Rajubabu Peela, Mr. Mogga Naga Varalakshmi, Mrs. Sita Ramayya Mogga, Mrs. Dakshayani Mogga, Mr. Sai Harish Rampe, Mr. Mogga Geetha Sankar, Mr. Sundar Syam Manohar Mogga. It is established to develop real-estate activities involving construction of residential apartments and commercial complexes in various parts of Vishakha Patnam and its surroundings.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuité’s policies.
