Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 6.00 crore bank facilities of Sadhana Enviro Engineering Services (SEES) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Bangalore based, Sadhana Enviro Engineering Services is a Proprietorship concern established in 2007, promoted by Mr. Nagaraj T S. Sadhana Enviro Engineering Services engages in manufacturing and assembling of Municipal Equipment such as Sewer Cleaning suction cum jetting machines, road sweeping machines and Garbage Compactors; majorly for Mysore City Corporation, Hubli Dharwad Municipal Corporation, Raichur Thermal Power Corporation Limited across the state of Karnataka. Apart from manufacturing/assembling and selling of machines, they carry out the after sales service activities, supply of spares/accessories, Operation and Maintenance of the equipment supplied to Corporations, Urban Boards, Water Boards among others.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
