Rating Rationale

Acuite has downgraded the long-term rating to 'ACUITE B (read as ACUITE B)' from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 10.00 crore bank facilities of Jai Hind Autotech Industries (JHAI) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Jai Hind Autotech Industries (JHAI) is an Uttarakhand based partnership firm established in 2016 by Mr. Puran Singh and his brother, Mr. Chetan Baghel. The firm is engaged in manufacturing of injection moulded plastic components for the automobile industry. The firm manufactures products including mirror hosing, A13 plug, gear lever and Apillars, among others. The manufacturing unit of the firm is located in Udham singh Nagar (Uttarakhand) with installed capacity of 2000 metric tonnes per annum.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability

Acuite endeavoured to gather information about the entity/industry from the public domain.
