Rating Rationale

Acuite has reaffirmed the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 24.00 crore bank facilities of Shankhadeep Exports Private Limited (SEPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Incorporated in 2008 by the Jana family of Kolkata, Shankhadeep Exports Private Limited is engaged in processing and export of sea food, primarily Vannami and black tiger prawns. Shankhadeep Exports Private Limited (SEPL) has its processing facilities at Kolkata (West Bengal). The facility has an aggregate installed capacity of 60 TPD for processing of seafood. The company has Star Export House status from the Government of India. The company exports its products mainly to Japan, Vietnam, China, Singapore, Malaysia and Thailand.

Non-cooperation by the issuer/borrower:
