**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs. 12.00 crore bank facilities of Super Max CNC Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Super Max CNC Centre Private Limited was incorporated in 2015 by Subramanian Deivanayagam and Rajeswari Subramanian. The company is based out of Chennai, Tamil Nadu and is engaged in Job work on CNC milling, CNC wire EDM, Super drills & Fixtures.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
