# **Rating Rationale**

Acuité has reaffirmed the long-term rating of **'ACUITE B-'** (**read as ACUITE B Minus**o)n the Rs.12.00 Crore bank facilities of Super Max CNC Centre Private Limited(SMCNCPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
