**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE B-**' (**read as ACUITE B minus**) on the Rs. 12.00 Cr. bank facilities of Nice Sanjay Rocks India Private Limited (NSRIPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Nice Sanjay Rocks India Private Limited (erstwhile Sanjay Rocks Granite India Private Limited), a Jaipur based company incorporated in 2012. It is promoted by Mr. Rakesh Kumar Gupta, Ms. Shalini Gupta, Mr. Bhanwar Lal Choudhary, Ms. Gouri Devi Choudhary and Mr. Ravi Bajjiya. The company is engaged in the manufacturing and export of granite and marble stones. Currently the day to day operations are managed by Mr. Rakesh Kumar Gupta.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
