Rating Rationale

Acuite has downgraded the long-term rating to ‘**ACUITE B-**’ (read as **ACUITE B minus**) from ‘**ACUITE B**’ (read as **ACUITE B**) on the Rs. 11.11 crore bank facilities of Shree Jagdamba Coke Industries Private Limited on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Established in 1972 as a partnership firm, the Jharkhand based Shree Jagdamba Coke Industries Private Limited was subsequently incorporated as a private company in 1993. The company is promoted by Mr. Kailash Agarwalla, Mr. Manish Agarwalla and Mr. Sanjeev Agarwalla. The Company manufactures low ash metallurgical coal with an installed capacity of 10800 MTPA.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
