Rating Rationale

Acuite has withdrawn the long term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.18.25 Cr. bank facilities of Tricon Polyfabs Private Limited (TPPL). The rating continues to be an indicative rating based on the best available information.

The rating is being withdrawn on account of the request received from the company and the NOC received from the banker as per Acuite's policy.

About the company

West Bengal based Tricon Polyfabs Private Limited (TPPL) was incorporated in 2014 by Mr. Surendra Agarwal and Mr. Rabindra Agarwal. The company is engaged in manufacturing of polypropylene woven bags, polypropylene woven fabric and biaxial oriented polypropylene bags, among others. The commercial operations of the company started from February, 2017. The manufacturing unit is located in the Burdwan district of West Bengal with an installed capacity to produce around 4000MT annually

Non-cooperation by the issuer/borrower

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
