## **Rating Rationale**

Acuité has downgraded the long term rating to 'ACUITE BB-' (read as ACUITE double B minus) from 'ACUITE BB' (read as ACUITE double B) on the Rs.10.15 crore bank facilities of Vaishnavi Auto Private Limited (VAPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

## **About the Company**

VAPL, based at Nashik (Maharashtra), was incorporated in 2000 promoted by Mr. Gajendra Wani and Ms. Surekha Wani. The company is engaged in the manufacturing and export of machined Components and auto electric components such as Fuel Injector System, Suspension System and Brake System, among others. The manufacturing unit is located at MIDC in Nashik (Maharashtra). The company caters to the domestic as well as overseas market.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

### Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
