Acuité has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs. 6.90 crore bank facilities of Sri Kaleswari Agro Farms (SKAF). This rating is now an indicative rating and is based on best available information.

The Karnataka based, SKAF was established in 2012 as a partnership firm by Mr. R S Venkateswara Rao, Mr. Chandrashekar and Mrs. R Naga Lakshmi. The firm is engaged in the business of trading of eggs and cull birds.

#### Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
