Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minus) on the Rs. 6.90 crore bank facilities of Sri Kaleswari Agro Farms (SKAF). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

The Karnataka based, SKAF was established in 2012 as a partnership firm by Mr. R S Venkateswara Rao, Mr. Chandrashekar and Mrs. R Naga Lakshmi. The firm is engaged in the business of trading of eggs and cull birds.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
