Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 8.00 crore bank facilities of Sri Vyjayanthi Labs Private Limited (SVPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

SRI VYJAYANTHI LABS PRIVATE LIMITED (SVPL), incorporated in July 1982, was taken over by the current management Mr. Mudunuri Venkata Satyanarayana Raju and Mrs. Sree Devi Mudunuri in 2008 from the previous management. The company is engaged in the manufacture of active pharmaceutical ingredients (APIs) and pharmaceutical intermediates. SVPL has its manufacturing facility at J.N.Pharma City in Visakhapatnam with an installed capacity of 50 Metric Tons Per annum.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
