Acuité has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 7.60 crore bank facilities of The Suguna Mills Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

The Suguna Mills Private Limited (TSPL) was incorporated in 1956. The Promoter of the company was Sri. G.V. Kasthurisamy Naidu. The company is currently managed by S. Suguna and B. Selvarajan who is having an experience of over five decades in the textile industry. It is engaged in the manufacturing of cotton yarn with spindles capacity of 14432 of count 80s and 100s. The Spinning unit of the company is situated at Sugunapuram, Palghat Road, Kunimthur, Coimbatore.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
