Rating Rationale

Acuité has withdrawn the long-term rating of '**ACUITE B** (**read as ACUITE B**) and the short-term rating of '**ACUITE A4**' (**read as ACUITE A four**) on the Rs.7.90 crore bank facilities of Cleantech Systems Private Limited (CSPL).

The rating withdrawal is in accordance with the Acuité's policy on withdrawal of rating. This rating continues to be an indicative rating and is based on the best available information.

The rating is being withdrawn on account of request received from the company and No Objection Certificate received from the banker.

Pune based, CSPL was incorporated in 2006 by Mr. Prashant Savardekar, Mrs. Pratibha Savardekar and Mr. Milind Mehendale. The company is engaged in the assembling of special purpose component cleaning machines, majorly for the automobile and pharmaceutical industry. The company has a shed with a total capacity of 6000 square feet.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
