## Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE BB' (read as ACUITE double B) and the short-term rating of 'ACUITE A4+' (read as ACUITE A four plus) on the Rs. 15.00 crore bank facilities of Sarvesh Multi Plast India Private Limited (SMPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

#### **About the Company**

Chennai-based, Sarvesh Multi Plast India Private Limited (SMPL) was incorporated in 2009 by Mr. Govindswamy. The company manufactures building construction materials such as UPVC door and window profiles and PVC bathroom doors, among others.

#### **Unsupported Rating**

#### Non-cooperation by the issuer/borrower:
