Kolkata based, SGPL was incorporated in the year 2010 by Mr. Ramakant Johari, Mrs. Ranjana Johari and Vijaykumar Soni. The company is mainly engaged in manufacturing and trading of precious and semiprecious metal Jewellery. The company has further diversified their revenue streams by venturing into the business of retail store of men and women's garments along with selling of furniture.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.
