Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE B-**’ (read as **ACUITE B minus**) on the Rs.15.00 crore bank facilities of Suryavanshi Gems and Jewellery Private Limited (SGJPL). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Kolkata based, Suryavanshi Gems And Jewellery Private Limited was incorporated in the year 2010 by Mr. Ramakant Johari, Mrs. Ranjama Johari and Vijaykumar Soni. The company is mainly engaged in manufacturing and trading of precious and semiprecious metal Jewellery. The company has further diversified their revenue streams by venturing into the business of retail store of men and women’s garments along with selling of furniture.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
