Acuite has reviewed the long-term rating of '**ACUITE D' (read as ACUITE D)** and short term rating of '**ACUITE D' (read as ACUITE D)** on the Rs. 51.00 crore bank facilities of Supreme Overseas Exports India Private Limited (SOPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

SOPL, is a Bangalore (Karnataka)- based company incorporated in 1998 by Mr. S. R. Ramchandrar and Mr. Sri Harsha. The company is engaged in manufacturing and exporting of finished leather and leather garments. The company exports its products to countries such as Italy, Germany, France, Denmark and Switzerland, among others.

#### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
