# Rating Rationale

Acuite has reaffirmed the long term rating of 'ACUITE BB-' (read as ACUITE double B minus) and the short term rating of 'ACUITE A4+' (read as ACUITE A four plus) on the Rs. 50.00 crore bank facilities of Fortuna Engineering Private Limited (FEPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

Maharashtra-based, Fortuna Engineering Private Limited was incorporated in 1993 by Mr. R. Suriyanarayanan. FEPL is engaged in machining and assembling of precision auto components such as connecting rods and camshafts for leading OEM's in India. FEPL has its manufacturing unit located in Nashik, Maharashtra.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
