Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 26.52 crore bank facilities of Hi Tech Ferrous and Non Ferrous India Private Limited (HTPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Hi Tech Ferrous and Non Ferrous India Private Limited (HTPL) is a Ghaziabad-based company, established in the year 2009 by Mr. Pradeep Garg and his family. The company is engaged in manufacturing and supplying of CHQ Wires, Trim Wires, Carbon Steel Wires and Alloy Steel Wires etc for auto ancillary manufacturing companies.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
