Acuite has reviewed the long-term rating of '**ACUITE B-** (read as **ACUITE B minus**) and the short term rating of '**ACUITE A4** (read as **ACUITE A four**) on the Rs. 19.00 crore bank facilities of Bremels Rubber Industries Private Limited (BRPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Karnataka based, BRPL was incorporated in 1971 by Late Mr. Bhaskar R Shetty. Currently, the second generation entrepreneurs, Mr. Nischith B Shetty and Mr. Adith B Shetty are the Directors and managing the company. The company is engaged in manufacturing tyre retreads used for retreading worn-out tyres of heavy vehicles. The company also manufactures solid tyres for forklifts.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
