Rating Rationale

Acuité has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) and the short-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) on the Rs. 62.50 crore bank facilities of Swastik Copper Private Limited (SCPL). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Jaipur based Swastik Copper Private Limited (SCPL) was incorporated in 1993 by Mr. Sandeep Jain who was supported by his father, Late Shri Shashi Kumar Jain. SCPL is engaged in manufacturing and distribution of power transformers ranging from 16 KVA 11 KV Class to 10 MVA 33 KV Class. The manufacturing unit is situated in Sitapura Industrial Area of Jaipur with a production capacity of 20000 transformers per annum.

Non-cooperation by the issuer/borrower:
