Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs.10.00 crore bank facilities of Vandana Trailors and Body MFG Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Established in 2008 by Mr. Trilok Chand Jaiswal and family, based in Chhattisgarh, Vandana Trailors and Body MFG Private Limited is engaged in manufacturing of Tip Trailor, Tipper Body, Flat Trailor and Box Trailor with the installed capacity of 1200 pieces per annum in the state of Chhattisgarh.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
