Acuité has reviewed the long-term rating of '**ACUITE B**' (**read as ACUITE B**) and the short-term rating of '**ACUITE A4**' (**read as ACUITE A four**) on the Rs. 7.00 crore bank facilities of Sinco Communication (India) Private Limited (SCPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Incorporated in 1996, SCPL is promoted by Mr. Ved Prakash Gupta and supported by second line of management including Mr. Vinod Bansal. The company is currently engaged in the manufacture of power cables which are used for lighting and electrification purposes. The company was previously engaged in the manufacture of steel drums but has shifted its business line since 2011. The registered office of the company is located in Delhi.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
