Acuité has withdrawn the long term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs.24.50 crore bank facilities of Somani Ecobuild Products LLP (SEP). This rating is now an indicative rating and is based on best available information.

The rating is being withdrawn on account of request received from the company and NOC received from the bank.

Somani Ecobuild Products LLP was established in 2016 by three partners, namely, Mr. Vedang Vyas, Mr Vikram and Mrs. Varsha Somani. The firm is engaged in manufacturing of dry mix Mortar for construction industry. The manufacturing facility is located at Kishangarh, Rajasthan. The products are sold under the brand name of MAGNICRETE.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
