Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 7.00 crore bank facilities of Monal Chains Limited (MCL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.
