Acuité has reviewed the long-term rating of '**ACUITE B+**' (**read as ACUITE B plus**) and short term rating of '**ACUITE A4**' (**read as ACUITE A four**) on the Rs. 11.00 crore bank facilities of Reflexion Narayani Impex Private Limited (RNIPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Reflexion Narayani Impex Private Limited (RNIPL), incorporated in 1994, is a Kolkata based company engaged in manufacturing and export of leather goods. Additionally, the company derives income from lease rental from its commercial property located in Kolkata. The company is promoted by Mrs. Sujata Mukhopadhyay, Mr. Satyabrata Mukhopadhyay and Mr. Rokhsar Parveen.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
