Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE BB**' (read as **ACUITE double B**) on the Rs.10.00 Cr bank facilities of Dhumal Industries India Private Limited (DIPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

DIPL (Erstwhile known as Dhumal Plasjon Equipments India Private Limited), a Maharashtra based company, incorporated in 1999, is promoted by Mr. Anil Dhumal, Ms. Tova Posner Henkin and Mrs. Shailaja Anil Dhumal. The company is engaged in designing, manufacturing and supplying of poultry equipment such as drinking and feeding system. Later, Mr. Akshay Anil Dhumal joined the company as a Director.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
