Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE BB**' (read as **ACUITE double B**) on the Rs.10.00 Cr. bank facilities of Dhumal Industries India Private Limited (DIPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Dhumal Industries India Private Limited (DIPL) (Erstwhile known as Dhumal Plasson Equipments India Private Limited), a Maharashtra based company, incorporated in 1999, is promoted by Mr. Anil Dhumal, Ms. Tova Posner Henkin and Mrs. Shailaja Anil Dhumal. The company is engaged in designing, manufacturing and supplying of poultry equipment such as drinking and feeding system. Later, Mr. Akshay Anil Dhumal joined the company as a Director.

Unsupported Rating

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
