Acuite has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.45.00 Cr bank facilities of Mourya Aquex Private Limited (MAPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the company

Incorporated in 2017, MAPL is an Andhra Pradesh based company currently undertaking a greenfield project to set up a sea food processing plant with facilities viz Individual quick freezer, feed, plant, cold storage, modern deep-freezing plant for processing of shrimps, lob star and crab. The company is promoted by Mr. Thota Pandu Ranga Jagadish and Mrs. Thota Sireesha.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
