## Rating Rationale

Acuite has withdrawn the long term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.5.88 crore bank facilities of A and A Infrastructure Private Limited(AAIPL).The rating withdrawal is in accordance with Acuite's policy on withdrawal of rating.

The rating is being withdrawn on account of request received from the company and NOC received from the banker.

Incorporated in 1996, promoted by Mr. Anuj Kaistha, A & A Infrastructure Private Limited undertakes civil construction works related to industrial, hospital and commercial buildings in Gurgaon.

### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date. This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

### Analytical approach

Acuite has considered the standalone financial and business risk profiles of MSP to arrive at this rating.
