Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE BB-' (read as ACUITE double B minus)** on the Rs.12.16 Cr. bank facilities of Shreeji Cotfab Limited (SCL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Rajasthan based Shreeji Cotfab Limited (SCL) was incorporated in 2010 by Mr. Kuldeep Singh (Managing Director). The company is engaged in trading and manufacturing of cotton and polyester yarn. SCL is a manufacturer, wholesaler, trader and exporter of Cotton Yarn, Melange Yarn, Hosiery Yarn, PC Yarn, and other types of yarns in India.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
