**The issuer did not co-operate; based on best available information.

Acuite has reviewed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs. 13.00 crore bank facilities of Maa Bhawani components and Fabrication Private Limited (MCPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

MCPL was incorporated in 2005 and started its commercial production from 2007. The company is currently engaged in the process of precision machining of components having application in the automobile industry and construction equipment manufacturing industry. MCPL is promoted by Mr. Ajay Kumar Singh. The manufacturing facility is located at Jharkhand.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
