Rating Rationale

Acuité has reviewed the long-term rating of '**ACUITE B**' (**read as ACUITE B**) on the Rs.12.00 crores bank facilities of Bhadrakali Autocare Private Limited (BAPL). This rating is now an indicative rating and is based on the best available information.

M/s Bhadrakali Autocare Private Limited (BAPL) was incorporated on 04.02.2019 as a Pvt Ltd company. BAPL was in the process of setting up a new Arena showroom for Maruti Suzuki India Ltd (MSIL). The Registered Office is located at Hanamkonda, Warangal-Telangana. The Company has taken leased land located in Lakshkar Singaram Revenue Village, Hanamkonda; Warangal -506001 for the establishment of Arena a showroom Maruti Suzuki India Ltd (MSIL).

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
