Acuité has reviewed the long-term rating of '**ACUITE B** (read as **ACUITE B**) and short term rating to '**ACUITE A4** (read as **ACUITE four**)' on the Rs. 12.00 crore bank facilities of Bellstone Hi-Tech International (BHI). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Delhi based, BHI was established as a partnership firm in 1973 by Mr. Madanlal Sethi and his son, Mr. Ashish Sethi (Managing partner). BHI is engaged in assembly and trading of Industrial Equipment and Construction Machinery.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
