Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B' (read as ACUITE B) and short term rating to 'ACUITE A4' (read as ACUITE four)' on the Rs. 12.00 crore bank facilities of Bellstone Hi-Tech International (BHI). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
