Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE BB**' (read as **ACUITE double B**) from '**ACUITE BB+**' (read as **ACUITE double B plus**) on the Rs.15.10 crore bank facilities of Harekrishna Rice Processing And Exports (HRPE) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Established in January 2015, Harekrishna Rice Processing And Exports (HRPE) is a partnership firm promoted by Mr. Anirudha Dash, Mr. Trilochan Dash, Mr. Ashirbad Dash and his family members. HRPE had set up an automated rice milling unit with processing capacity of 57600 MT per annum in Jajpur, Odisha and commenced its commercial operations in 2018. The firm is engaged in milling and processing of paddy into non-basmati rice.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
