Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 6.27 crore bank facilities of Bhagwansharan Constructions. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Jaipur based Bhagwansharan Constructions is a partnership firm established in 2015 by Mr. Bhawani Singh Shekhawat, Mrs. Neelam Shekhawat and Mr. Abhimanyu Singh Shekhawat. The hotel was started in November, 2018 under the name and Style 'HOTEL COUNTY INN' with 42 rooms, restaurant, Banquet Hall and open garden space for marriages and garden.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
