Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE C**' (read as **ACUITE C**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.12.00 crore bank facilities of Sunpower Cement Company Private Limited. The rating continues to be flagged as "Issuer Not Cooperating" and is based on best available information.

About the Company

Sunpower Cement Company Private Limited (SCPL), incorporated in 2005, is promoted by Mr. Shameer Dawood and Mrs. Razni Shameer. The company is engaged in manufacturing of Portland Pozzolana Cement (PPC) and operates from Kanjikode, Palakkad, Kerala. The Company procures the clinker from Chettinad Cement Corporation Ltd, Jaypee Cement Corporation Ltd, Sagar Cements Limited, Dalmia Cement (Bharat) Ltd. The Registered office of the company is in Ernakulam.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
