Rating Rationale

Acuite has reaffirmed the long term rating of 'ACUITE C' (read as ACUITE C) and the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs.12.00 crore bank facilities of Sunpower Cement Company Private Limited. The rating continues to be flagged as "Issuer Not Cooperating" and is based on best available information.

About the Company

Sunpower Cement Company Private Limited (SCPL), incorporated in 2005, is promoted by Mr. Shameer Dawood and Mrs. Razni Shameer. The company is engaged in manufacturing of Portland Pozzolana Cement (PPC) and operates from Kanjikode, Palakkad, Kerala. The Company procures the clinker from Chettinad Cement Corporation Ltd, Jaypee Cement Corporation Ltd, Sagar Cements Limited, Dalmia Cement (Bharat) Ltd. The Registered office of the company is in Ernakulam.
