#### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B)from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs.10.00 Cr. bank facilities of Sree Rama Constructions (SRC) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### About the Company

Sree Rama Constructions (SRC) is a partnership firm established in 1997 by Mr. Govardhan Reddy and others. The Hyderabad-based civil construction firm undertakes civil contracts mainly for Telangana and Andhra Pradesh government. The firm is registered as Special Category I contractor. The firm mainly undertakes contracts for roads, bridges, power and irrigation.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
