Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) on the Rs. 30.00 crore bank facilities of Shri Mahabir Dyeing and Printing Mills Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Based in Mumbai and incorporated in 1982, Shri Mahabir Dyeing and Printing Mills Private Limited is engaged in and sale of cotton textile products like printed sarees and dress materials, blouse pieces etc. The day to day operations are managed by its directors, Mr. Subhash Ganeriwal, Mr. Ankit Ganeriwal and Mr. Naresh Agarwal. The manufacturing facility is located at MIDC Industrial Area, Dombivali. The production capacity is about 1.00 lac meter per day.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
